8 Important Information for Applicants

a. Change of Name

If you have changed your name or if any of your documents show a name which is different from this application form, then you must present certified documentary evidence of the change.

b. International Student Registration Fees

All international students registering with and receiving an offer from James Cook University are required to pay International Student Registration Fee of S\$864.00 (incl. GST). The fees cover a range of services provided to international students by James Cook University and is paid together with other fees stipulated in Student Contract.

c. Regulation of Student Pass

International students holding a Student Pass issued by the Singapore Immigration and Checkpoints Authority (ICA) are strictly forbidden to engage in any form of employment during the validity of their student pass.

d. Fee Protection Scheme (FPS)

James Cook University is EduTrust Certified. The EduTrust certification scheme which is administered by the Committee for Private Education (CPE), a part of SkillsFuture Singapore (SSG) requires all students to be covered under a Fee Protection Scheme. In James Cook University, this is provided through an insurance protection scheme. This insurance serves to protect the students' fees in the event that James Cook University is unable to continue operations. Furthermore, the FPS protects the student if the school fails to pay penalties or return fees to the student arising from judgments made against it by the Singapore courts. This scheme also provide for insurance that entitles you up to SGD\$10,000 coverage upon death or total permanent disability.

e. Inter-campus Exchange Program

Inter-campus Exchange Program approvals are dependent on policies and requirements which govern the approvals. It is not guaranteed or compulsory that you must go on a Inter-campus Exchange Program while you study at the Singapore campus of James Cook University.
